Mode of exam Phase 1 pre-screening: OMR based.

The selection for all the posts notified from <u>Level-4 to Level-9</u> will be done through a combination of Pre-Screening and Trade/Skill test examination.

The examination will be comprised of two parts – Phase- 1 (Pre-Screening) and Phase- 2 (Trade/Skill Test). All the candidates will have to appear in Phase-1 examination. After declaration of the results of Phase- 1 examination, 10 candidates securing highest marks in Phase-1 exam will be shortlisted and shall appear for Phase 2 Trade/skill test related to the job profile of particular post. The final selection will be made on the basis of merit of Phase 2 examination only.

- CANDIDATE NOT FULFILLING THE ELIGIBILITY CRITERIA AS PER RECRUITMENT RULES (RR) OF NIPER FOR THE VARIOUS POSTS, WOULD NOT BE ALLOWED TO APPEAR IN PHASE 2 (TRADE / SKILL) TEST EVEN AFTER QUALIFYING PRE-SCREENING TEST.
